Teaching and assessment

The course combines legal study with legal skills, and places an emphasis on commercial and corporate law. It is taught by an academic and solicitor with considerable experience in the field, using a variety of practical and academic teaching methods. You will be expected to develop your skills in relation to written and oral communication, team and individual working, independent learning, research and argument construction and analysis, using these skills within a commercial law environment. You will attend lectures for the core subjects with other law students.

European Legal Studies LLB Honours

This course encourages an interest in the European dimension of law. With this Qualifying Law Degree, graduates who wish to become barristers or solicitors are granted exemptions by the professional bodies concerned. On graduation you will have satisfied Law Society/Bar Council requirements and will have spent a year studying law in another European country.

When you apply you will need to demonstrate an aptitude for European language study, but this need not necessarily take the form of a formal qualification.

Course content

Alongside your Law modules, you will study a European language in Year 1 and Year 2 (Credit Levels 4 and 5) so that you can cope with studying in another European country. You will then spend 10 months studying law at one of the universities in the European Union that maintain links with the School of Law. These offer a wide range of law courses, including some taught in English. We have partner institutions in Belgium, France, Germany, Greece, Italy, the Netherlands, Spain, Sweden and Portugal. This scheme allows you to experience another legal culture, develop links in Europe, and gain knowledge of other legal systems, while studying for a Qualifying Law Degree. You may qualify for an Erasmus grant.

This course provides you with the core subjects required by the professional legal bodies. You will also be able to study a wide range of distinctive modules, many of which reflect the research interests of the staff. The legal professions require graduates to possess both intellectual and practical skills, and the course explicitly addresses these requirements with a structured programme of skills development.

The course commences with a short induction course to the University, the School and the study of law. You will study core subjects, law options and free choice modules, including opportunities to study outside of the School, such as a language or a social science module. Direct entry

Direct entry to Year 2 or 3 is only possible in exceptional circumstances, if you have already successfully completed a course compatible with Year 1, or Year 1 and 2 of our LLB. You should give reasons (with evidence) for wishing to transfer, and must have entry qualifications comparable to those needed to enrol at Credit Level 4 at Westminster. We may not be able to make a decision until all your previous results are available. Direct entrants should have achieved a minimum average of 55 per cent in all modules (not including pass/fail modules) prior to their application to transfer.

Admission to Year 3 is rarely granted. Students at this stage of the course should check their proposed programme of study with the appropriate professional body to ensure that they are eligible for a Qualifying Law Degree (details from the Bar Standards Board Education, Training and Records Department for barristers, or the Solicitors Regulation Authority for solicitors).

Lectures, used for large groups, are supported by smaller seminar or tutorial sessions. You will develop the skills of independent study and research. You will be assessed using a variety of methods ranging from presentations and essays to formal exams. Most subjects have some element of course work that, in some modules, accounts for all of the mark.

General Studies/Critical Thinking will not be considered as a third A Level but will be considered with other subjects. You may also be invited to attend an interview.

This course gives you the opportunity to spend a year studying law in France, gaining invaluable experience of another legal culture while acquiring knowledge of its language and legal system.

With this Qualifying Law Degree, graduates who wish to become barristers or solicitors are granted exemptions by the professional bodies concerned. On graduation, you will have satisfied Law Society /Bar Council requirements and will have spent a year studying French law at a French university.

When you apply, you will need to demonstrate a good working knowledge of French to ensure you are able to study in France in your third year of study.

Course content

The course provides you with the core subjects that are necessary for a Qualifying Law Degree. You will also study French language modules, French law and legal language. Once you complete Year 2 (Credit Level 5) you will spend 10 months at a French university and study law in French, giving you the opportunity to obtain a French legal qualification. Arrangements exist between the University of Westminster and the universities of Bordeaux, Nancy, Nice, Paris X Nanterre and Toulouse.

The course allows you to gain knowledge of the French legal system, experience the French legal culture and develop links in France while studying for a qualifying law degree. You may also aualify for an Erasmus grant.

This course is one of only four in the country, and the only one in London and the South East. It gives you both a Qualifying Law Degree and exemption from the requirement to undertake the Legal Practice Course (LPC). The course is geared to professional practice, and you can start your training to become a solicitor as soon as you graduate.

From the start of the course you will be given an introduction to the skills required by lawyers. This prepares you for the clinical experience you will acquire in Year 3 and the clinical options in Year 4, where you will work with real clients on real cases. Fees are consistent throughout rather than nearly tripling at the LPC stage, so the course offers a more accessible route to becoming a solicitor while providing the experience that future employers are looking for.

Course content

The general ethos of the course is one of integration of the academic and practical. In Years 1 and 2 you will cover the same core subjects as you would on a Qualifying Law Degree. Alongside these subjects you will study two modules in Legal Ethics, Method and Skills (LEMS) which have been specifically designed for this course. These modules provide you with an introduction to professional ethics and skills, together with the traditional study skills course.

In Year 3 you will build on the foundations provided in these LEMS modules to conduct real cases with real clients. You will carry out this work under supervision and with appropriate training. You will also study a mixture of academic and practical subjects. Year 4 is entirely devoted to the practical subjects that would ordinarily be studied on the Legal Practice Course, while you will be given a further opportunity to work with real clients on a clinical option. Most modules are double modules.

Teaching and assessment

Associated careers

On completion you will carry out a period of work-based learning (currently called a training contract) under the supervision of a solicitor. There are a wide variety of career options as a solicitor, from private practice in commercial firms in the City of London or high street firms, to being an employed lawyer with organisations such as the CPS and the legal departments of major corporations. Law graduates are also sought after in a wide range of non-legal careers. Students completing the course, or those choosing to leave with a Qualifying Law Degree after three years, can also begin to train as a barrister.
