



## Law

Durham Law School is a centre of international excellence in both legal scholarship and research. A Durham postgraduate Law qualification will provide you with an excellent foundation for a career in the legal profession.

### **ABOUT THE SCHOOL**

Durham Law School was ranked fourth highest Law School in the UK in the 2008 Research Assessment Exercise, having returned 100% of its staff in the RAE. The ranking is based on the percentage of submissions graded 4\* (world-class).

Durham Law School has particular strength in the areas represented by the Human Rights Centre (HRC), the Institute for Commercial and Corporate Law (ICCL), the Centre for Criminal Law and Criminal Justice (CCLCJ), the Durham European Law Institute (DELI), the Centre for Gender and Law at Durham (GLAD) and the Law and Conflict at Durham (LCD) cluster.

The main part of the Law School is located just a few yards from Durham's ancient castle and from our own dedicated law library. Our postgraduate office is opposite the County Court. Our excellent library resources include electronic access to journals, case law and update services through databases such as HeinOnline, Westlaw, LexisNexis and other Butterworths' packages, as well as hundreds of direct electronic law journal subscriptions.

### MAIN AREAS OF RESEARCH

The Durham Law School is one of the UK's leading centres for legal research and provides a dynamic and vibrant environment for developing your research interests.

The following is a brief overview of the major areas of research in the School, but these are not the only areas in which our staff are research active. We would encourage you to refer to staff profiles on our website for further information about individual research interests.

- English private and commercial law: particularly international trade law, corporate law, contract law, tort law, law and economics, restitution, equity, Europeanisation of private law, consumer law and commercial fraud and intellectual property
- UK public law: particularly human rights, comparative constitutional law, separation of powers and scrutiny of security services





- Law and medicine: particularly bioethics and intellectual property issues
- Human rights: particularly the Human Rights Act, counter-terrorism issues, media freedom, religious liberty, international human rights law and discrimination law
- Criminal law and criminal justice: particularly international criminal law, criminology and corporate liability. The Centre for Criminal Law and Criminal Justice is currently engaged in a project on Islamic Criminal Justice
- Public international law: particularly international human rights law, international humanitarian law, conflict studies, international criminal law and WTO law
- Legal theory: particularly moral philosophy, socio-legal studies and theory of international law
- EU law: particularly constitutional law, external trade, competition law, Third Pillar matters
- Gender and law: particularly discrimination, women in the legal professions, equality and diversity, gender and crime.

### POSTGRADUATE RESEARCH FACILITIES

In addition to dedicated research training facilities for postgraduate research, we also provide postgraduate student workrooms with extensive IT facilities, support for attendance at external conferences and student-led research seminars. All research students are attached to the School's research clusters and centres, which run regular seminars in which research students are required to deliver papers.

### TYPICAL ENTRY REQUIREMENTS FOR RESEARCH DEGREES

- MJur: Law degree with at least a good upper second class Honours (or equivalent)
- PhD, MPhil: Law degree with at least a good upper second class Honours (or equivalent); strong preference is given to those who also have a recognised Masters degree for which we normally expect an average grade of at least 65% (or equivalent).

## ENGLISH LANGUAGE REQUIREMENTS:

• IELTS of 7.0 (on every component) or equivalent.

### TAUGHT PROGRAMMES LLM in International Trade and Commercial Law

This programme offers students from a wide variety of backgrounds the opportunity to develop their legal knowledge and skills in some of the most intellectually challenging and practically relevant areas of trade and commercial law. The course has a particular emphasis upon

the international aspects of these areas of legal knowledge and practice.

Students attending the programme are drawn from a broad range of countries, and their previous academic or professional experiences enrich the programme. The School is host to the Institute of Commercial and Corporate Law, and students on the LLM are encouraged to participate in its activities.

## LLM in European Trade and Commercial Law

This programme provides an opportunity to develop an advanced knowledge of the law of the European Union, with particular emphasis upon its commercial aspects. If you are new to European law, there is a (compulsory) foundation course providing a solid grounding in the subject. Having completed your choice of taught modules, you will then undertake an extended dissertation on a European law topic of your choice. The School is host to the Durham European Law Institute, and you are encouraged to participate in its many activities. The library, which includes a European Documentation Centre, has extensive holdings of European materials.

### General LLM

This programme gives you the widest choice of modules. It is ideal if you wish to select modules from those available in each of the specialised LLM programmes. Having completed your taught modules, you will undertake an extended dissertation of 10,000, 15,000 or 20,000 words in length, under the supervision of a member of staff who is an expert in your chosen field of research.

Teaching is by a mixture of lectures and smaller student-led seminars. The dissertation is pursued by independent research under the guidance of a supervisor. You will benefit from the excellent resources available through the School's dedicated law library, and are encouraged to participate in the many activities undertaken by the School's research clusters. Please note that we regularly introduce new modules, and not all modules may be available each year.

## TYPICAL ENTRY REQUIREMENTS FOR TAUGHT PROGRAMMES

• A good 2:1 degree (or its equivalent) in Law, or in a degree in which law is a major component.

Durham Law School recruits around 175 undergraduate and 100 taught postgraduate students each year. In addition, there are over 47 postgraduate research students. Our complement of over 30 full-time members of staff within the Law School, many of whom teach on the LLM programmes, is comprised of researchers of distinction and high reputation, as well as a number of promising early career researchers. Students can, however, undertake their dissertation with any member of staff which provides students with a wide choice of topics, from Advanced Law of Obligations to Public International Law.
