

# Tuition fee regulations 2012-2013 NHTV Breda University of Applied Sciences

In 2012/2013, NHTV charges the following tuition fees:

# Statutory tuition fee

You pay the statutory, statutory+ or partial statutory tuition fee for a study programme at NHTV if you comply with the following conditions:

- You satisfy the nationality requirement. This means that you have the nationality of a country that is part of the European Economic Area (EEA)<sup>re3</sup>or the Surinamese or Swiss nationality. You also satisfy the nationality requirement if you have a residence permit which entitles you to the Dutch student grant; <u>and</u>
- You live in the Netherlands, Belgium, Luxembourg, or one of the German federal states of Nordrhein Westfalen, Niedersaksen or Bremen <sup>re4</sup>; <u>and</u>
- You don't already have a bachelor's degree before you start on your bachelor's programme at NHTV; and you don't already have a master's degree before you start on your master's programme at NHTV; and
- You are enrolled on a government-funded programme at NHTV.

If you do not meet <u>all</u> above stated requirements, an institution fee is applicable.

• For students who have exceeded their study time with more than one year over the nominal programme duration <sup>re7</sup> the statutory, statutory+, partial statutory of institution fee equal to the statutory fee will be raised with the longtime study fine ('langstudeerderstoeslag').

#### Delayed studies enactment ('langstudeerdersmaatregel')

A new legislation has been introduced which contains a raised statutory fee for delayed students ('langstudeerders'). A delayed student is a student that has exceeded his study time with more than one year over the nominal programme duration. <u>All enrolled years</u> at Dutch universities or universities of applied sciences add up for this legislation.

The nominal programme duration is the number of years the programme will take if you don't have any study delay. For a programme of 240 ECTS this is 4 years. For an AD programme this is 2 years. For a master programme of 60 ECTS this is 1 year.

For the academic year 2012-2013 the fine has been set at  $\in$  3.063,-. The delayed studies enactment fine applies for full-time, part-time and dual students.

The delayed studies enactment fine applies only for bachelor and master students who are eligible for the statutory, statutory+, partial statutory or institution fee equal to the statutory fee.

### Re1. Statutory+ fee Media and Entertainment Management

Within the framework of the experimental act 'Ruim baan voor talent', NHTV is allowed to select 100% of its students for the Media & Entertainment Management programme, as well as charge them a tuition fee which is €475 higher than the regular statutory tuition fee.

### Re2. Institution fee wo bachelor Tourism (joint degree)

Institution fees for the wo bachelor Tourism (joint degree) are equal for both NHTV as well as Wageningen University.

### Re3. European Economic Area

The European Economic Area (EEA) includes all countries that are part of the European Union (EU), along with Liechtenstein, Norway and Iceland.

The EU countries are: Belgium, Bulgaria, Cyprus, Denmark, Germany, Estonia, Finland, France, Greece, Hungary, Ireland, Italy, Latvia, Lithuania, Luxemburg, Malta, the Netherlands, Austria, Poland, Portugal, Romania, Slovenia, Slovakia, Spain, Czech Republic, United Kingdom, Sweden.

You have to be officially registered in the municipal personal records database ('Gemeentelijke Basis Administratie' (GBA)) with your current residential address.

#### Re4. Country-of-residence principle

NHTV Breda does not offer distance courses. Students who do not live in the Netherlands, Belgium, Luxembourg, or one of the German federal states of Nordrhein Westfalen, Niedersaksen or Bremen at the time of enrolment (reference date 30 September) will have to pay the institution fee. You have to be registered in the GBA administration with this address.

# Re5. Students who already possess a bachelor degree

Students who obtained a bachelor's degree (or equivalent degree) after 1 Augustus 1991 in the Netherlands will have to pay the institution fee<sup>1</sup>. NHTV Breda applies 1 exception to this requirement: students who enrol for the same bachelor's programme in 2012/2013 as in 2009/2010 + 2010/2011 + 2011/2012 will pay the fee that is equal to the statutory fee, provided that they have not completely used up their nominal study years<sup>2</sup> and they meet the other conditions to qualify for the statutory fee.

#### Re6. Institution fee master's programmes Media Innovation (full-time)

Students who enter the master's programme in Media Innovation and who meet the requirements for the statutory fee, will have to pay an institution fee that is equal to the statutory fee.

Students who enrol for master's programme in Media Innovation and who **do not** meet the requirements for the statutory fee, will have to pay an institution fee which is equal to the master's fee as set for the other master's programmes of NHTV.

## Re7. Nominal programme duration

The nominal programme duration is the number of years the programme will take if you don't have any study delay. The nominal programme duration can be determined by dividing the total amount of ECTS by 60. E.g.: for a programme of 240 ECTS this is 4 years. For an AD programme this is 2 years. For a master programme of 60 ECTS this is 1 year.

#### Re8. Exam fee for 'extraneus' students

The exam fee for 'extraneus' students will be determined on a case-by-case basis.

#### **Re9. Administration costs**

Tuition fees can be paid all at once or in 10 instalments. When the fee is paid in instalments, an administration fee of €25 will be charged.

# Explanation of tuition fee regulations - NHTV Breda University of Applied Sciences 2012–2013

# Reduced tuition fee or exemption from tuition fee

The legal regulations regarding a reduced tuition fee or exemption from the tuition fee only apply to the statutory tuition fee. NHTV Breda always applies these regulations in the same way to their institution tuition fees. An exception to this rule is: students are only eligible for a reduced tuition fee or exemption from the tuition fee on the grounds of their enrolment at another institution, if they pay the statutory tuition fee, not if they pay the institution tuition fee.

This rule only applies to bachelor's and associate degree programmes, not to master's programmes.

#### **Refund of tuition fee**

The provisions in the regulations regarding enrolment and termination of enrolment and tuition fee refund in the case of early termination of enrolment only apply to the statutory tuition fee. NHTV Breda applies these provisions in the same way to their institution tuition fees.

The provisions regarding tuition fee refunds only apply to bachelor's and associate degree programmes, not to master's programmes.

#### No tuition fee for a second enrolment

While attending a bachelor's or master's programme you can take courses of another study programme or do a complete second study programme (at the same education institution or another one), as long as you have not yet completed your degree. You will not be charged any additional tuition fee on top of the statutory tuition fee already paid for the first bachelor's or master's programme.

An exception to this rule: students are only eligible for a reduced tuition fee or exemption from the tuition fee on the grounds of their enrolment at another institution, if they pay the statutory tuition fee, not if they pay the institution tuition fee.

Students enrolled on more than one study programme at NHTV Breda, only pay the tuition fee once. This applies to the statutory tuition fee as well as the institution tuition fee. In situations like this, the highest tuition fee will be charged.

# Subject to change

The tuition fee as stated on the standing order form or payment slip is subject to change. Upon checking its records, the student administration office may discover that you fall into a different tuition fee category than initially assumed. This will only happen if you don't comply with certain conditions. So, make sure to carefully read all the above-mentioned information about the tuition fee procedures of NHTV Breda.

#### Unforeseen cases

In unforeseen cases, the Board of Governors will decide.
